Explanation of Responses:

- The new grant is for 7,731 shares of common stock represented by performance-based restricted stock units. The restrictions may lapse on 2,551 shares in each of February 2009 and February 2010, and on 2,629 shares in February 2011 contingent on meeting a corporate operating cash flow target for each of the 2008, 2009 and 2010 performance periods. The restrictions may lapse on any unvested units in February 2011 based on a cumulative three-period corporate operating cash flow target.
- The new grant is for 6,326 shares of common stock represented by time-based restricted stock units. The restrictions will lapse on 2,087 shares in February 2009, on 2,088 shares in February 2010, and on 2,151 shares in February 2011.
