 PERFORMANCE UPDATE FOR OCTOBER 2009**

Due to the timing of certain items, October was higher than the trend, while September was lower. The average of these two months was in line with Management’s expectations of a mid-9 percent rate.

⁽²⁾ Managed data for the month of October excludes a small program that has been terminated. It is not in Private Label’s top 20 programs and is not considered material based on revenue or credit sales.
