Explanation of Responses:

- The new grant is for 5,081 shares of performance-based restricted stock. The restrictions on 100% of the shares may lapse in February 2004 if certain Company financial targets are met. If the restrictions do not lapse in February 2004, the restrictions may lapse in February 2006 if certain performance standards are met.
- The total number of securities beneficially owned includes: (a) 1,334 shares acquired through the Company employee stock purchase program; (b) 28,000 shares of restricted stock granted 8/31/01, of which 11,200 shares are vested; (c) 2,000 shares purchased in the open market; and (d) the new grant for 5,081 shares.
- The new option is for 28,919 shares, of which 9,543 shares will vest on each of 6/23/04 and 6/23/05 and 9,833 shares will vest on 6/23/06.
- The total number of derivative securities beneficially owned includes: (a) an employee stock option for 50,000 shares granted 9/26/02, of which 16,500 shares will vest on each of 9/25/03 and 9/25/04 and 17,000 shares of which will vest on 9/25/05; (b) an employee stock option for 50,000 shares granted 8/30/01, of which 16,500 shares vested on 8/29/02, 16,500 shares will vest on 8/29/03 and 17,000 shares will vest on 8/29/04; and (c) the new option for 28,919 shares.
