Explanation of Responses:

- The new grant is for 14,049 shares of common stock represented by time-based restricted stock units (RSUs). These time-based RSUs will vest over a three-year period, with 4,636 units vesting on each of 2/18/25 and 2/17/26 and 4,777 units vesting on 2/16/27, subject to continued employment (subject to certain limited exceptions) by the Reporting Person on the vesting dates.
- Shares withheld by the Company to satisfy the Reporting Person's tax withholding obligation upon the vesting of restricted stock units.
- The total number of securities beneficially owned includes: (a) 6,624 unrestricted shares; (b) 2,952 unvested units from an award of 8,681 time-based restricted stock units granted 2/15/22; (c) 8,036 unvested units from an award of 11,993 time-based restricted stock units granted 2/15/23; and (d) the new grant for 14,049 time-based restricted stock units.
