Explanation of Responses:

- The new grant is for 8,826 shares of common stock represented by time-based restricted stock units. The restrictions will lapse on 2,912 units on 2/15/23, on 2,913 units on 2/15/24 and on 3,001 units on 2/18/25, subject to continued employment by the Reporting Person on the vesting dates.
- The new grant is for 13,239 shares of common stock represented by performance-based restricted stock units, which may be adjusted up or down at the time the performance restriction lapses. The restriction may lapse with respect to 100% of such shares on 2/18/25 contingent on meeting predetermined performance measures and subject to continued employment by the Reporting Person on the vesting date.
- The total number of securities beneficially owned includes: (a) 11,385 unvested time-based restricted stock units granted 7/15/21; (b) 3,623 unvested performance-based restricted stock units granted 7/15/21; (c) the new grant for 8,826 time-based restricted stock units; and (d) the new grant for 13,239 performance-based restricted stock units.
