Explanation of Responses:

- Based on the Company's cash EPS growth in 2010, 107% of the original award of 13,296 performance-based restricted stock units granted 2/22/10 were earned, resulting in an additional 930 units, for a total of 14,226 units. The restrictions will lapse with respect to 4,742 units on each of 2/22/12 and 2/22/13, subject to continued employment by the Reporting Person on the remaining vesting dates.
- Shares withheld by the Company to satisfy the Reporting Person's tax withholding obligation upon the vesting of restricted stock units.
- The total number of securities beneficially owned includes: (a) 5,452 unrestricted shares; (b) 3,281 unvested units from an original award of 4,896 time-based restricted stock units granted 12/21/09; (c) 2,228 unvested units from an award of 3,324 time-based restricted stock units granted 2/22/10; and (d) 9,484 unvested units from an award of 14,226 performance-based restricted stock units granted 2/22/10.
