### ALLIANCE DATA PROVIDES PRIVATE LABEL PERFORMANCE UPDATE FOR MAY 2009

**Dallas, TX, June 15, 2009** – Alliance Data Systems Corporation (NYSE: ADS), a leading provider of loyalty and marketing solutions derived from transaction-rich data, today provided an update on its Private Label Credit segment.

In conjunction with the release of the Company's Master Trust Monthly Noteholder's Statement, the Company is releasing similar metrics for the overall total managed portfolio. The Master Trust data represents a subset of the Company's total managed portfolio, and the Company believes the information presented below provides a more complete view of the Private Label Credit segment.

(1)May's loss rate is consistent with the second quarter's seasonal drift upwards for credit losses. June's loss rate is currently running favorable to May's rate. For the quarter, the loss rate is expected to be in the high 9s. Additionally, any incremental increase in the loss rate versus guidance is expected to be mitigated by lower costs of funds.
